1. 2. This waiver, release and discharge shall be and operate separately in favor of the Club, its members and all persons, corporations involved in such activities and all sponsors and shall so operate whether or not the loss, injury or damage is attributable to the act or negligence of any one or more of them.
3. I acknowledge that sailing is a hazardous sport and I accept that hazard.
4. I agree to indemnify the Club and the members of the Club should any claim be made against them for injury, loss or damage arising out of any act or omission by me.

INSURANCE

All owners of vessels competing in Vaucluse Yacht Club Events must hold current and adequate insurance to cover possible property and personal damage claims. Furthermore, all owners are to ensure their vessel's insurance fulfills this requirement as defined and required by the Vaucluse Yacht Club's "Race Entry" conditions

**Vaucluse Yacht Club (VYC)
Rack Rental Agreement**

I agree to take a rack/s for the storage of the craft, as detailed below, stored for the purpose of participation in racing or otherwise, and continuing on from year to year unless otherwise cancelled by 14 days notice in writing by me, or by the VYC in terms of its by-laws. If the craft is not to be stored for the purpose of participation in racing, I accept that the right of storage is not continuing, and is subject to written request for continuance at the time of renewal each year. The VYC may grant extension, or terminate the agreement with 14 days notice.

I agree to pay the charges fixed by the Club from time to time. The full amount of rental shall become due immediately on the signing hereof for a year in advance. If I terminate the agreement before the expiration of a full year, no rebate of rental shall be applicable. Termination by the VYC shall attract a pro-rata rebate.

I acknowledge that storage is subject to the VYC By-laws, and that the Club may exercise its common law or other rights, via a lien on stored property or otherwise, in recovery of any outstanding debt owing by me under this agreement or as a consequence of my membership.

I accept that my craft is stored at the VYC at my own risk and that all insurances in respect of same will be my absolute responsibility, and further that I relieve indemnify the VYC, its officers and members against any claim arising out of loss or damage to my craft whilst it is so situated however so caused.

I accept that:

- My craft must be of a size under 4 meters in length or otherwise suitable to the rented rack space, and that it must be stored in the rack allocated, and not left in or obstruct the passageway;
- Identification number, or owners name, must be displayed on the stern.
- Storage of craft and gear must be orderly and contained within the space rented, and must not interfere with storage of other craft or the operation of the Club. Security of personal property is my responsibility.
- I will not store fuel, or other inflammable or dangerous substances, within the club without prior and specific approval of the VYC.
- Storage of craft in support of racing takes precedence over storage of other craft.

The craft whenever used is this document includes the physical entity and all sails, gear and equipment relating thereto.
